Cherry Bar Recipe
(preheat oven 350 degrees)

4 eggs (beaten first)
1/2 C Butter
1/2 C Shortening
1 1/2 C Sugar
1 C Milk
1 tsp Vanilla Extract
1 tsp Almond Extract
1 1/2 tsp Baking Powder
3 C Flour
1 can Cherry Pie Filling (21 oz)

-Mix all ingredients, except Cherry Filling.
-Spread 2/3 mix in grease 9x13 pan.
-Spread can of Cherry Filling on top.
-Top with remaining mix.
-Bake 40-45 min.
(bake time was not written, until golden brown, check w/ toothpick)
-Cool before applying glaze

Glaze
2/3 C Powdered Sugar
1 1/2 T Milk
-mix well and apply
